

## NORTH CAROLINA SCHOOL IMMUNIZATION REQUIREMENTS (2015-2016 SCHOOL YEAR)

The North Carolina General Statutes (G.S. 130-A-152(a)) require immunizations for every child present in this state. Every parent, guardian or person in loco parentis is responsible for ensuring that their child(ren) receive required immunization.

### **DTP/DTaP (5 doses)**

Fifth dose (second booster dose) on or after fourth birthday, before enrolling in K-1 for first time; if the fourth dose of DTP/DTaP was administered on or after the fourth birthday a fifth dose is not required.

### **Measles (2 doses)**

One dose on or after age 12 months and before age 16 months; second dose at least 28 days later and before entering K-1 for the first time.

### **Rubella (1 dose)**

One dose on or after 12 months and before age 16 months.

### **Hepatitis B (3 doses)**

3 doses required. The last dose of the hepatitis B vaccine series shall not be administered before 24 weeks of age.

### **Hib (4 doses)**

Vaccine not required if individual has passed 5th birthday; number of doses required varies by age.

### **Mumps (2 doses)**

One dose on or after 12 months and before 16 months; second dose before entering school for the first time after 7/1/2008.

### **Varicella (1 dose)**

One dose is required on or after 12 months of age and before 19 months of age. This is not a requirement for students born before 4/1/2001. As of 7/1/2015, documentation from a provider or designee is required to verify history of disease.

### **Varicella (2 doses)**

Individuals entering K-1 for the first time on or after 7/1/2015 are required to receive a second dose of varicella vaccine prior to entering school.

### **Polio (4 doses)**

As of 7/1/2015, the booster dose must be on or after the fourth birthday and before entering K-1 for the first time; if the third dose of polio vaccine was administered on or after the fourth birthday and at least six months from the second dose, a fourth dose is not required.

### **Tdap (1 dose)**

One booster dose of Tdap vaccine is required for individuals who have not previously received it and are entering the seventh grade or by 12 years of age, whichever comes first, on or after 7/1/2015.

### **Meningococcal (1 dose)**

One dose is required for students entering the seventh grade or by 12 years of age, whichever comes first, on or after 7/1/2015. This dose is not a requirement for individuals born before 1/1/2003.

**Rule Change Affecting School Grade Cohorts:**

<b>Mumps</b>	Individuals entering school for the first time on or after 7/1/2008 are required to have a second mumps vaccine.
<b>Varicella (1 dose)</b>	Required to have 1 dose of varicella if born on or after 4/1/2001.
<b>Varicella (2 doses)</b>	Individuals entering school (K-1) for the first time on or after 7/1/2015 are required to have a second dose of varicella vaccine.
<b>Polio</b>	Booster dose on or after the fourth birthday and before entering K-1 for the first time. (Regardless of the number of previous doses)
<b>Tdap</b>	Booster dose of Tdap required for those entering the 7th grade or by 12 years of age, whichever comes first, on or after 7/1/2015.
<b>Meningococcal</b>	Individuals entering the 7th grade or by 12 years of age, whichever comes first, on or after 7/1/2015 are required to have one dose of meningococcal vaccine.
<b>All students</b>	See N.C. Administrative Code for specific requirements and exceptions: DTaP/DT/Td; Polio; Measles; Mumps; Rubella; Hib; Hepatitis B; Varicella
