SUBJECT: ALERT: McKesson Specialty Packing Slip Changes for NCIP Providers

The purpose of this memo is to alert NCIP providers of changes to the McKesson **packing slip** included with state-supplied vaccine shipments. McKesson began including this updated packing slip with all vaccine shipments on June 20, 2011. Please note that the content remains the same as the information included on the previous packing slip; only the look has changed.
