Please complete this form with your requested influenza vaccine doses. **Please refer to the July 2nd memo for the product presentation to calculate the number of doses needed.** NCIP will be taking orders to pre-book the influenza vaccine for the 2012-2013 flu season. **In order to receive influenza vaccine in a timely manner, pre-book requests must be submitted via fax (1-800-544-3058) or e-mail ([flu.2012-2013@dhhs.nc.gov](mailto:flu.2012-2013@dhhs.nc.gov)) BY 3PM on JULY 27, 2012.** Pre-book requests received after this date will not be processed until after all other orders have been shipped in full. This is a very important process in trying to avoid wastage of vaccine while at the same time assuring that there is an adequate distribution of influenza vaccine.

**Modifications/Cancellation:**

Orders may be modified or cancelled by your facility until 3 PM on August 17, 2012. Please note that orders that are not cancelled on or before 3 PM on August 17, 2012 will be filled according to the original request.
