SUBJECT: Enhancements to the North Carolina Electronic Disease Surveillance System (NC EDSS)

The purpose of this memo is to follow up on the North Carolina Immunization Program (NCIP) memo dated April 1, 2014, *Changes to the North Carolina Perinatal Hepatitis B Program*. Enhancements have been implemented in NC EDSS to meet the reporting requirements set forth from the Centers of Disease Control and Prevention (CDC) for the Perinatal Hepatitis B Program. The following questions have been added to NC EDSS:
